All bills are to be settled prior to your dog being dropped off.

All dogs are to remain on the premises until payment is made unless agreed otherwise. In the event a bill is left un-paid it will incur late fees 14 days after an invoice has been issued. Invoices may be issued by electronic means including text messaging, telephone, emails, and or mail. Late fees will incur a flat rate charge of £5 per day for 28 days; the final stage is that the debt will be given to a debt collection agency. All dogs left on the premises after the period of the agreed collection date will remain on the property for a further month incurring further charges, upon reaching the period of one month after the date of collection it is accepted that the Doggy Dorchester will now take ownership of the dog and begin seeking means to rehome them.

PAYMENTS

Every Booking requires a £100 deposit unless its less than a £100 stay. This can be done in advance of your booking if you would like to secure a certain date (we recommend doing this during our very busy periods). You can cancel up to two weeks before to get a full refund.
